

SOUTHWEST ADA LITTLE LEAGUE PARENT'S CODE OF CONDUCT

Southwest Ada Little League has implemented the following Parent Code of Conduct for the important message it holds about the proper role of parents in supporting their child in sports. Parents must read, understand and sign this form prior to their children participating in our league. Any parent/spectator guilty of improper conduct at any game or practice will be asked to leave the sports facility and be suspended from the following game. Repeat violations may cause a multiple game suspension, or the season forfeiture of the privilege of attending all games.

The essential elements of character-building and ethics in sports are embodied in the concept of sportsmanship and six core principles. The highest potential of sports is achieved when competition reflects these "six pillars of character":

- Trustworthiness
- Responsibility
- Caring
- Respect
- Fairness
- Good Citizenship

I therefore agree:

- 1) I will not force my child(en) to participate in sports.
- 2) I will remember that children participate to have fun and that the game is for youth, not adults.
- 3) I will inform the coach of any physical disability/ailment that may affect the safety of my child(en) or others.
- 4) I will learn the rules of the game and the policies of the league.
- 5) I (and my guests) will be a positive role model for my child(en) and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game, practice or other sporting event.
- 6) I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, player, or parent such as booing and taunting; refusing to shake hands; or using profane language or gestures.
- 7) I will not encourage any behaviors or practices that would endanger the health and well being of the athletes.
- 8) I will teach my child(en) to play by the rules and to resolve conflicts without resorting to hostility or violence.
- 9) I will demand that my child(en) treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex or ability.
- 10) I will teach my child(en) that doing one's best is more important than winning, so that my child(en) will never feel defeated by the outcome of a game or his/her performance.
- 11) I will praise my child(en) for competing fairly and trying hard, and make my child(en) feel like a winner every time.
- 12) I will never ridicule or yell at my child(en) or other participants for making a mistake or losing a competition.
- 13) I will emphasize skill development and practices and how they benefit my child(en) over winning. I will also de-emphasize games and competition in the lower age groups.
- 14) I will promote the emotional and physical wellbeing of the athletes ahead of any personal desire for my child(en) to win.
- 15) I will respect the officials and their authority during games and will never question, discuss, or confront coaches at the game field, and will take time to speak with coaches at an agreed upon time and place.
- 16) I will demand a sports environment for my child(en) that is free from drugs, tobacco, and alcohol and I will refrain from their use at all sports events.
- 17) I will refrain from coaching my child(en) or others during games and practices, unless I am an official coach of the team.
- 18) I will volunteer sufficient time for the benefit of my child(en) in the role indicated during registration (minimum 10 hours). I also understand that I have the option to pay an "opt-out" fee to avoid volunteering.
